

## Contest Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. ALL FEDERAL, PROVINCIAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

**1. Eligibility:** Minix Neo Storage Giveaway (the "Contest") is open to worldwide residents that are their countries' minimum legal age at the time of entry. Employees of DrekiTech and other companies associated with the promotion of the Contest, and their respective parents, subsidiaries, affiliates, advertising and promotion agencies as well as the immediate family, spouses, parents, siblings, and children and household members of each such employees are ineligible. The Contest is subject to local laws and void where prohibited.

**2. Sponsor:** The Contest is sponsored by DrekiTech and Minix. No other website listed herein or on the contest page is associated with the contest.

**3. Agreement to Official Rules:** Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize requires compliance with these Official Rules and fulfilling all other requirements set herein.

**4. Contest Period:** The Contest begins July 27, 2019 at 12:00:01 GMT +12 and ends on August 11, 2019 at 00:00:01 GMT +12 (the "Contest Period"). Entries that are submitted before or after this period will be disqualified. Submissions will be accepted for the duration of the Contest using any of the following methods:

### How to Enter:

Contest entry will be available by visiting our website (<http://dreki.tech/contest>) and following the directions provided to fill out the entry information, and submit.

*Limited to one (1) e-mail address entry per person, and per household for the duration of the Contest Period, regardless of method of entry. Entries received from any person, e-mail address, or household in excess of the stated limitation will be void. All entries become the property of Sponsor and will not be acknowledged or returned.*

**6. Prize Drawing:** On or about August 13, 2019, the Sponsor will select potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via email on or about August 13, 2019. If the potential winner cannot be contacted within two (2) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

**7. Winner Notification:** The potential winners will be notified by email, or if a minor wins, the prize winners (parent/legal guardian) will be required to complete, electronically sign and submit a Declaration of Compliance within two (2) days of the winning notice is sent, in order to claim his/her prize. If a potential winner cannot be contacted or fails submit the Declaration of Compliance within the required time, or prize is returned as undeliverable, the potential winner forfeits prize. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to damage the website or undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

**10.
